# Background to the Second Stakeholder Consultation Round

The first consultation round with stakeholders, held in Brussels on 27 March 2014, revealed a possibility for a new approach to pursuing the strategic aims of EGF's current research on the Karabakh context. The Brussels consultation round alluded to the **creation of a platform for exchange of information** between Armenian and Azerbaijani experts on energy, transport, trade issues, the rehabilitation of the territories affected by the conflict and the return of IDPs to their homeland. Such exchanges could lead to development of post-conflict scenarios, based on a roadmap leading towards an economically integrated South Caucasus, underpinned by a number of very broad and uncontroversial principles. These include the right of all people to live in an environment of peace and security; a shift in government strategy from preparing for war to building enduring peace and fostering economic development; good neighborly relations as a basis for peace building; the right of all people to strive for economic prosperity; and the right of all IDPs and refugees to return to their homes and/or lands and live there in peace and security.

## Session I: Post-conflict regional cooperation in the South Caucasus: A strategic plan for regional development?

Our ongoing research suggests that economic drivers are unlikely to be a panacea for conflict resolution in the Nagorno-Karabakh (NK) context. However, it likewise shows that expert discussion on economic issues may be highly useful in 'preparing the ground' for some level of flexibility in the current rigidity which grips the parties regarding NK. Starting a public debate amongst NK stakeholders on the advantages/disadvantages of choosing peace and regional economic development over the current state of hostility may ease some of the tension in the NK context. This view appears to be broadly supported within international peace building circles relevant to NK. The aim of this session is to explore, together, the scope of a "strategic plan for regional development", or a "blueprint for economic development in the South Caucasus" as a key trigger for such a public debate. Could 'elements of cooperation' lead to

something far bigger and grander if a strategic plan for regional development could be articulated by experts from Armenia, Azerbaijan and international circles working together?

# Session II: Considerations of business and investment: reintegrating post-conflict Karabakh within the regional South Caucasus economic framework

Our research has highlighted that business people in both Armenia and Azerbaijan do not consider cooperation with one another as a viable option at the present time. However, the need to involve the business community in the discussion on post-conflict regional economic scenarios was a recurring message from the Brussels consultation round. Some voices from the region call for Karabakh to become the modern day *Alsace-Lorraine* of the South Caucasus, implied to mean a thriving zone of regional significance, where important historical cultures intersect and economies thrive. Others, in the same spirit, call on the region to become a "free economic space", where abundant investment from Azerbaijan will one day be welcome. At the purely commercial level, such investment may eventually come in the form of joint projects between Armenians, their Azerbaijani neighbours, as well as international partners, replacing the many missed opportunities forced on the region as a result of conflict and tension.

The aim of this session is to examine the role that business could play in the regional economic development in a post-conflict scenario in the NK context. Would Armenian and Azerbaijani businesses be willing to invest in this region of the Caucasus? Could region-wide investment projects 'sweep up' NK as part of a future regional economic boom? Are we too fixated on security questions relating to Karabakh and missing immense opportunity by seemingly ignoring scope for economic cooperation? Could Armenians and Azerbaijanis, possibly from Diaspora communities, as well as Turkish, Russian and other investors see incen-

tives in the development of joint commercial projects in the region? Can we work together towards a blueprint for regional economic development, at least in the form of a strategic policy documents for decision makers and foreign investors? What is the opinion of business leaders about the overall 'prospects for NK', were an appropriate political climate to emerge?

## Session III: Post-conflict scenario building workshop and group simulation

The aim of this workshop is to simulate a negotiation process in order to reflect a possible real life situation which may occur in the NK context at a future date, and to draw lessons learned during a feedback session.

#### Scenario

In April 2019 a peace agreement based on the (current) Madrid Principles has been reached between the Republics of Salandia and Oronia. In May 2019, the presidents of Salandia and Oronia, working under the auspices of the Minsk Group, have established a bi-national Task Force mandated with drawing up a roadmap for implementation of the economic considerations of the Peace Agreement. The Task Force is charged with agreeing upon projects, timetables, and other contentious issues for implementation of these economic priorities. Furthermore, the Task Force is invited to propose additional economic projects that can act as confidence building measures by addressing the restoration of war-torn energy, transport and socio-economic infrastructure in NK and the territories around it by establishing, where possible, 'economic projects of common interest'.

## Participants' goals

Your task will be to simulate negotiations of the above mentioned Task Force. You will need to employ your respective areas of expertise in order to creatively negotiate within the above scenario that a Peace Agreement over NK has been reached and that a road map for its implementation is now high priority. Your objective is to 'thrash out' negotiations on economic considerations of the road map to ensure its smooth and timely implementation, taking into account the interests of your countries and the key components of the Peace Agreement. The end goal is to agree upon an "official" Road Map document which can be supported by both parties. You will also be asked to make press statements during a mock press conference. More detailed instructions will be provided in due course.

# **IBRAHIM AHMADOV**

Mr Ahmadov finished his PhD in 2012 at the University of Cologne (to be published). He is involved in numerous academic initiatives, such as the Arnoldshain Conference on the "Nagorno Karabakh peace process" at the *Peace Research Institute Frankfurt*, and the Mannheim Center for European Social Research's Seminar "The Mountainous Karabakh conflict between Armenia and Azerbaijan: internal and external conditions of the conflict solution".

Since early 2012 he has worked at the *Azerbaijan Student Network* in Berlin, first as a staff member and then as Chief Executive. He speaks Azerbaijani as his mother tongue, is fluent in Ger-

man, English and Russian, has very good Turkish, and average Arabic.



# CHRISTIAN CLEUTINX

Mr Christian Cleutinx, a Belgian, is an international expert in energy security, diplomacy and international dialogues between 'east and west'. He has over 30 years of experience as an international civil servant and practitioner in geopolitics, international relations and energy with a special emphasis on Russia and the United States. Up until 1 April 2011, he was the Director General of the Euratom Supply Agency at the European Commission. At the present time he advises and lectures on energy policy and geopolitics at universities, think tanks and international institutions. Earlier in his career, following academic studies in Belgium and the United States, he joined the European Commission in 1975 and has occupied several positions in the field of energy policy. # **DR VUSAL GASIMLI**

Assoc. Prof. Dr Vusal Gasimli works as a Head of Department in the Center for Strategic Studies under the President of the Republic of Azerbaijan. He was president of "ANS-PRESS" Publishing House from 2005-2007 and EU expert in 2009-2010. He graduated from Azerbaijan State Economic University and received his Master degree in Economics in 1997. He received an MA in Journalism from the Georgian Institute of Public Affairs (based on the study program of Louisiana State University) in 2004. He received a PhD in Economics at the Scientific-Research Institute in Baku in 2009.

Being a results-driven researcher with a strong background in macro-economics, he focuses his studies on economic development, competitiveness, modernization and agriculture. In recent years, he has hosted and participated in more than 20 academic research projects, published about 500 articles, and wrote or co-authored 10 books. A recent book entitled "Resourcerich countries: Modernization and Diversification" was printed by the German Academic Publishing House in 2013. Dr Vusal Gasimli was given the award of Astana Economic Forum for outstanding research achievements in 2012. He worked as a guest scholar in the Korea Institute for International Policy in 2013. He has delivered lectures at prestigious universities such as Washington, California, Hanyan, Milan Catholic, Warsaw, Hankook, and Cairo, among others. # VAHAGN GHAZARYAN

Mr Vahagn Ghazaryan has over 19 years experience in the fields of trade policy formulation, trade related legislation drafting, and developing economic research and analysis. He has considerable experience in dealing with policy development in a state's official capacity while heading a department of WTO and EU affairs in the Ministry of Economic Development of RA. Being involved in the processes of RA trade policy formulation and regional trade facilitation and implementation of multilateral trade rules, he was a key participant of Armenia's accession to the WTO and implementation of post-accession commitments. He was responsible for the revision and drafting of RA trade-related legislation to ensure their compliance with WTO rules and regu-

lations. He took part in different bilateral and multilateral negotiation teams, such as: RA-Iran FTA, RA-EU PCA and ENP AP preparation, RA-NATO IPAP, among other teams on trade, economic, and political dialogue related issues.

One of the main directions of his expertise is exploring the ongoing trade policy developments in the RA, and working in close cooperation with different (governmental and nongovernmental) agencies delivering reports, suggestions and provisional drafts. Dr Terterov is also a Research Fellow at the Energy Charter Secretariat Knowledge Centre in Brussels, responsible for the design and delivery of a range of training programmes for the younger generation of energy leaders, as well as the drafting of strategy papers analysing the onward evolution of the Energy Charter Process. Furthermore, he is the Executive Director and co-founder of the Brussels Energy Club, a newly established information exchange platform for senior energy professionals.
